Applicant organizations must be a 501(c)(3) non-profit organization or a government instrumentality such as a municipality or public school district. The organization must directly or indirectly support students or job seekers interested in advancing their career in Civil Engineering, Public Works Administration or closely related field. Consideration will be given to experience related to the field of public works, stated goals of the organization, financial need, ability to introduce new individuals to the field of public works and its opportunities, and overall effectiveness of the organization to achieve the Diversity Grant objective.

### III. AWARD AMOUNT is \$2,000

All applicants must submit a letter of reference from a client, student or a public works professional indicating knowledge of the applicant's interest in advancing careers in the field of public works.
