**Project of the Year Award.** The **City of Minneapolis** received the Project of the Year Award for the Hiawatha Maintenance Facility. Accepting the award on behalf of the city was **Greg Goeke**, Interim Director of Property Services. In addition, the city's project team included **RSP Architects** and **Knutson Construction**.

The Hiawatha Maintenance Facility project renovated and preserved an existing 10-acre City maintenance facility site into a new facility opened in April 2010, and is pending LEED Platinum certification. The project was the City of Minneapolis' first LEED Platinum facility, and is the first public works maintenance facility in the country to achieve such an exemplary level of sustainable design. The project was completed on time and on budget.

## APWA-MN Board reviewing member survey feedback

The goal of the APWA-MN Board of Directors has been — and always will be — to ensure the chapter continues to meet the needs of the membership while adhering to the chapter’s mission statement.

The mission of the APWA-Minnesota Chapter is to advance the theory and practice of the design, construction, maintenance, administration, and operation of public works facilities and services. The purpose of the Minnesota Chapter is to exchange information and experiences; promote improved and sustainable best practices in the public works field; expect that all public works association members will adhere to high professional and ethical standards; and improve the professional and social involvement of its members, as set forth in the “Rules Governing Chapters of the American Public Works Association.”

We think this is especially important to emphasize during these challenging economic times and heightened media scrutiny.

In an effort to “check-in” on some of the services we provide, a membership survey was recently sent to all members. The survey focused on two main events: the annual Spring Conference, held in recent years at Grand View Lodge in Brainerd; and the Summer Golf Outing, typically held at Indian Hills Golf Course in Stillwater.

The Board is currently reviewing the results, taking inventory of the responses, and working to incorporate many of the suggestions. While no definite changes have been made to date (based on Board discussion and approval), the Conference Planning and the Membership Activities & Special Events committees will begin working to identify potential improvements and recommend incremental changes to both of these events so as to better serve member needs.



**Spring Conference.** The Conference Planning Committee will be gathering for its first Spring Conference planning meeting in early 2011. The goal of the Spring Conference is to provide a less technical, more management- and personnel development-based agenda. This distinguishes it from the Fall Conference, which traditionally provides attendees with a full range of technical sessions and presentations on current trends and practices within the public works community. The Conference Planning Committee will be discussing several options, based on responses to the survey, which may include revising the Spring Conference schedule/agenda to incorporate additional sessions and/or technical tours, or perhaps moving from a three-day to a two-day conference.

**Summer Golf Outing (Membership Drive).** The summer golf outing has historically been held on a Monday in mid-July. As indicated by survey responses, this poses a conflict for many of our public sector members who regularly attend council meetings on Mondays. Therefore, the Membership Activities & Special Events Committee will be looking into the possibility of moving the Summer Golf Outing to another day of the week in order to attract more municipal members. Other incremental changes that may be incorporated in the coming years relate to event location, type of dinner, and the possible elimination of door prizes.

## Update from the MN2050 Committee

The MN2050 Committee has been busy since the Spring Conference. At the July meeting, we started to lay the ground work for the collection of information that will be the basis for everything moving forward. We decided we needed to begin with some basic questions and follow this format so we could have continuity in the process.

We divided the group into five distinct groups:

- Airports/Aviation: Including all forms of aviation, commercial, medical, freight, business, and general flights.
- Ports: All water ports
- Transportation: Roads, bridges
- Rail
- Water, Waste Water, Storm Water

We asked each group to answer four questions:

1. Describe current infrastructure type? How does infrastructure benefit the daily lives of Minnesotans and the economic development of the state?
2. What are the five major initiatives (and, by example, five projects that support those initiatives) or infrastructure investments that need to be addressed statewide?
3. What is the trend line? Are things getting better or worse?
4. What can people expect if an adequate level of funding is not maintained?

At the October meeting, each group gave a short presentation of their findings and submitted their comments. The information will eventually make it to the MN2050 web site for review.

**Fall Conference presentation.** We also presented information at the APWA-MN Chapter at the Fall Conference. **Tom Eggum**, TKDA (representing ASCE), **Patti Craddock**, Craddock Consulting (representing CSWEA), and **Dan Gage**, representing our chapter, gave an update on how the committee got started, its goal and purpose, where we are in the process, some examples of the information gathered, and where we are headed in the next year. Judging by some of the feedback, the presentation was well received and several people expressed interest in getting involved.

Our hope is to educate the public about infrastructure and how it affects their daily lives. To show how infrastructure affects our economy and how if all of the organizations on the committee work together we can put Minnesota in a better position economically in the long run. We want to be a collection point of information, and provide tools to help everyone educate the public.

**Future plans.** We will be speaking again in January at a couple meetings representing partners of the committee and trying to get the word out to everyone involved in our various professions. We will also be holding a committee meeting sometime in late January or early February so if you would like to get involved please contact **Dan Gage**.

Self-assessment uses the Public Works Management Practices Manual as a valuable tool for determining how an agency's policies, procedures, and practices compare to recommended practices identified by nationally-recognized experts in the field of public works.

Agencies can use the recommended practices contained in the manual as a model for developing or improving existing practices to enhance performance, increase productivity, and to strengthen employee morale.

Some of the benefits of self-assessment include:

- Improve effectiveness.

- Clarify budget needs.
- Identify operation and management needs.
- Identify duplication and wasted effort.
- Promote team work and staff development.
- Promote team work and staff development.
- Improve communication.

A self-assessment review will prepare an agency for accreditation should it choose to take the next step.

## Where Are They Now? Lowell Odland

Lowell Odland started his career at Banister Engineering (now SEH) in 1956. Much of his work included design and construction of the sewer system in Roseville.

After a short career change to serve as the assistant city engineer of St. Louis Park in 1962, Lowell was contacted by the City of Roseville. Through his past work with the city, they decided to create a public works department. So, in 1964, Lowell accepted the position as the head of the newly created public works department. Lowell worked for the City of Roseville for three years when his dream job at the City of Golden Valley opened up. Lowell was the director of the Golden Valley Public Works Department from 1967 until 1991 when he retired.

Lowell became involved with APWA-MN when he was working for the City of St. Louis Park in the early '60s. His boss was involved and encouraged Lowell to become involved as well.

Lowell recalls many Fall Conferences held on the University of Minnesota campus (Nolte Center). Attendance was about 35 people and it snowed every year during the conference. He always made it; but, it wasn't as pleasant a drive for the attendees from Worthington, Albert Lea, and Rochester.

Lowell looked forward to those conferences. The ability to share information among colleagues and socializing with a great bunch of people.

His best memories in addition to the annual spring and fall conferences, were the national Congresses. He recalls many occasions where he and Dewey Kasma would skip out of the sessions and join the spouse's tours. It allowed them to spend time with their wives, as well as see the sights of the town other than engineering projects.

Lowell eventually went on to serve as president of the Minnesota Public Works Association (former name) in 1984. He also served as secretary/treasurer in 1982 and vice president in 1983.

What is Lowell doing now? Golfing, bowling, and going to his grandkids' sports events ... and loving every minute of it. His grandkids range in age from 21 years down to three-year old twin boys. Lowell also enjoys woodworking when he has time, but his busy life has seemed to get in the way of that hobby.

As many of you will agree, Lowell says the biggest change he has noticed is the difficulty of getting projects through the federal process. He remembers the good 'ol days when life was simpler. He also remembers when city councils were a little easier as well. No declaration of political preferences, no special interests — just business people who cared about their community and ran the community like their business.

Words of wisdom: "When you're able to retire, do it!" He explained that this allows more time for golf.

Lowell and his wife, Evie, reside in Shoreview during the winter and in Amery, Wisc., during the summer. After owning a lake home in Amery since 1991 (and a different lake home since 1977), they decided to move to a townhouse on the Amery golf course.

## Attend a technical tour! You don't know what you're missing

We all get the announcements about APWA-MN technical tours. If you're like most of us, you read it, pause for a moment and, unless it sounds spectacular, you probably convince yourself that you have better things to do. Well, if you missed the last two technical tours, I hate to tell you that you made the wrong decision and missed some really great stuff.

**Spring Technical Tour.** The spring technical tour was held as a part of the 2010 Spring Conference in Brainerd. It included a bus tour of the Whitefish chain of lakes, and a historical presentation at the Crosslake dam site which controls the water elevation for this chain of lakes.

I initially thought the tour was going to be just a nice ride in the country and a presentation of information that I thought I already knew. Like others at the conference, I spent a lot of time in this area growing up and thought I knew most everything about the area. Boy, was I ever wrong. I discovered that I was frankly clueless as to how this area truly developed and why the Cross Lake dam was initially constructed.

I found out that the Cross Lake dam and the dams on Leech, Winnibigoshish, Pokegama, Big Sandy, and Gull lakes were originally constructed to help relieve low water level problems in the Mississippi River during the summer months, and not for flood control. Back in the early 1900s, prior to the current lock and dam system, running barges on the Mississippi River was extremely difficult during the summer due to low water levels.

Apparently, the Pillsburys were successful in convincing federal and state agencies that this summer problem was significant and needed to be addressed. The solution called for holding back water in significant watersheds that drained to the Mississippi River, and then strategically releasing water during low-flow periods to increase water levels on the river so barge traffic could maneuver. In order to do this, dams were constructed on these five lakes and management of the system was given to the Corps of Engineers so all interests could be addressed, especially those of the logging industry.

The presentation also included additional historical information, and how the popularity of this area changed how the dam was operated.

### **City of Minneapolis Hiawatha Maintenance Facility Technical Tour.**

The most recent technical tour included a tour and presentation of the new Minneapolis Hiawatha Maintenance Facility. I wasn't able to attend this tour, and after listening to the presentation of this project at our recent Fall Conference, I really regretted missing it. What a cool project, and very deserving of the 2010 Project of the Year Award.

The project consisted of the city taking their 90-year-old Hiawatha Maintenance Facility, which included an abandoned asphalt plant, and converting it into a state-of-the-art maintenance facility that is LEED certified.

They essentially took the entire site and recycled everything, including metal beams, concrete slabs, wood, bricks, switchboards, and even pieces of the old Lowry Avenue Bridge, and incorporated these things into the new site. One very fascinating recycled feature was that the city reused old underground tanks from the asphalt plant as components of the storm water treatment and conveyance system.

So, my advice is to think twice before deciding not to attend the next technical tour. You may really regret it afterwards.
