

Learning from the pros at the Spring Conference

The 2011 APWA-MN Spring Conference was another outstanding success!

Wednesday evening opened with a presentation by APWA President **George Crombie**, who shared thought-provoking words about leadership. Crombie and **Larry Stevens**, APWA Region VI Director, presented **Mike Eastling** with the APWA Top Ten Award. It was great to see one of our colleagues recognized for his contributions to the community that he works for, and to the Minnesota Chapter and its ongoing education and training efforts. In addition, the organization received the proclamation signed by Gov. Dayton for National Public Works week. Thank you to our Mn/DOT partners for their assistance in obtaining the proclamation.



Former WCCO Anchor **Don Shelby**'s keynote message on
Wednesday night began with his history as a "keeper of secrets," based on his extensive investigative reporting background and history as a reporter and anchor.

On Thursday, he focused on how to get your story told by working with the media. Some key points:

- 1. Understand the scope of your project or program and how it will impact those you serve.
- 2. Anticipate questions that may be asked about your work, anticipate possible reaction, and know how to respond.
- 3. Role play with your colleagues and look for the holes in your program or project. You may find that your program or project can be improved. You will be better prepared for questions from the public and the media.
- 4. When being interviewed, understand that the camera represents your audience. Talk to the camera and be mindful of your posture.

5. Build relationships with the press. They need you to do their job, and you need them to help send a message.

Next, Lisa Schaefer Rund, League of Minnesota Cities, provided an overview of social media, how cities are using it, and special considerations for implementing social media. Shannon Tyree, Saint Paul Public Works; TK Kramascz, Mn/DOT; and Jennifer Bennerotte, City of Edina; led a presentation about of social media. This exceptional panel of communications professionals gave examples for the effective use of YouTube, Facebook, and Twitter, and helped us recognize that social media is now mainstream communication.

Thursday morning ended with the business meeting, as well as with the Leadership Academy graduation. The 2011 class had 11 graduates, many of whom were able to attend the conference and the graduation ceremonies.

Thursday afternoon provided several technical sessions and touring options. Attendees participated in a social media workshop, or explored the Gull Lake Recreation area by bus, bike or foot.

The Membership Committee helped with the association's scholarship fund by organizing a drawing for the opportunity to win a two-night stay at Grand View Lodge. Congratulations to **Mike Rardin** for winning the drawing! Thanks to the committee for its work to raise over \$1,000 for the scholarship fund.

On Friday morning, **Craig Johnson**, League of Minnesota Cities; and **Margaret Donahoe**, Transportation Alliance; discussed legislative issues of interest to public works professionals. Mn/DOT Deputy Commissioner and Chief Engineer **Bernie Arseneau** and **Peggy Reichert** with the Mn/DOT Office of Capital Programs and Performance Measures, updated us on Mn/DOT initiatives, ranging from ADA to MinnesotaGo.

The conference concluded with **Kristofer Layon** asking us to think about the use of technology in the future. He emphasized that it is not the technology itself about which we should be excited, but how we can use technology to convey information.

Delegate's Report (May 2011)

Membership. APWA's overall membership count as of April 2011 is 28,453. The Minnesota Chapter has 919 members.

Regional Delegates Meeting. The Region VI Delegate's meeting was held May 20-21 in Kansas City. Attendees included Regional Director Larry Stevens; chapter delegates from South Dakota, Kansas, Iowa, Nebraska, Missouri, Kansas City Metro, and Minnesota; and APWA President George Crombie. Reports from each chapter were presented. Some interesting highlights included:

- Once every three years, the Missouri, Iowa, Nebraska, and Kansas chapters host the Mid-America Conference, which includes educations sessions and an exhibit floor. At this year's conference, they hosted a National Public Works Week luncheon that had over 900 attendees.
- The Kansas City Metro Chapter assigns two Board members to each goal of their strategic plan for the purpose of implementation.
- The lowa Chapter uses the APWA new member promotion in conjunction with conference registration to attract new members.
- The Missouri Chapter hosts "mock interviews" for several members of their student chapter to help prepare the students for their future.
- The Kansas Chapter is pursuing development of a database of retired professionals interested in continuing to serve public works communities on an advisory basis.
- The Manitoba Chapter will host their Spring Fling in Winnipeg on May 27, as well as the 2012

- Mid-Canada Snow Conference in October. This may be an opportunity for Minnesota Chapter members to mingle with our friends to the north.
- The other chapters were very interested in Minnesota's young professional stipend program and have asked us to prepare an article for the next Bridge's newsletter. There was also interest in the success of our chapter's outsourcing of the bookkeeper/accounting function to APWA. The Minnesota Chapter was one of the first chapters to pilot this new service agreement with APWA, and many chapters would like to follow.

 Crombie and Regional Director Larry Stevens for
 the wonderful education sessions and hospitality
 that they received during the Minnesota Chapter's
 Spring Conference. They enjoyed meeting everyone.

City of Woodbury wins environmental award

On January 12, the Minnesota Chapter presented its 2010 Environmental Stewardship Award to the Woodbury City Council. The presentation followed

the award presentation at the chapter's Fall Conference in November. The award highlighted Woodbury's long-term commitment to environmental protection and stewardship.


The Awards Committee and **Environmental Committee noted** that the city's environmental efforts involve all departments, particularly the Engineering, Public Works, and Parks departments and environmental divisions, who

cooperated in submitting the award application. The city's commitments and staffing for environmental programs and projects began in 1994.

The annual Environmental Stewardship Award is given to a group, individual, or organization that demonstrates a sustained effort and long-term commitment to environmental stewardship. The recipient must identify tangible benefits to the community, and how its efforts address public works values such as cost-effectiveness and consideration of operation and maintenance needs.

Some of Woodbury's strongest environmental efforts include its storm water management initiatives, strategic initiatives related to water conservation and pricing, "complete streets" approach to roadway corridor design, snow and ice control program, and fleet and building

management strategies that implement sustainable practices.



Mayor Mary Giuliani Stephens accepted the award on behalf of the Council and the city. She thanked the Minnesota Chapter, and noted that the Council is committed to the

sustainability goals and principles that are the focus of Woodbury's 2030 Comprehensive Plan.

The City of Shoreview also submitted a strong application for the Environmental Stewardship Award in 2010. Shoreview has a strong commitment to sustainable storm water, building design, energy use, and transit practices.

The Environmental Stewardship Award is presented annually to celebrate the efforts that many public works departments, professionals and staff are making to protect and improve the environment, manage costs, and use resources effectively.

its website (www.apwa.net) and is reaching out to chapters to identify options for partnering on the development of their websites.


Meanwhile, APWA-MN is moving ahead with our own website initiative, establishing a Website Development Task Force to identify what features our members would

Public Works Program builds experience and advances careers

The Public Works Certificate Program at North Hennepin Community College has been in existence for over 30 years and has seen hundreds of public works professionals complete the program during that time. For many front line maintenance workers, the program has helped them to advance into public works supervisory roles.

The program consists of 23 credits, 16 of which are considered the core public works courses with the remaining seven credits coming from an elective communications course and a writing course. The four public works courses that make up the core 16 credits of the program are: Public Works Management and Communication, Public Works Operations and Maintenance, Public Works Organization and Administration, and Technical Aspects of Public Works. These core courses are taught by public works practitioners that have extensive knowledge and experience in their field.

The current instructors include Gary Brown, Rod Pletan, Tom Struve, and Paul Backer. These individuals are the reason the program has continued to be so highly regarded by agencies and professionals in the public works field.

In the past 18 months, the APWA-MN Education & Training Committee has formed a Public Works Certificate Program Steering Committee. The committee has been working with the instructors and college to ensure the program remains strong and vibrant for years to come. The committee has met numerous times and is currently pursuing new initiatives and possible course offerings for the program.

If you or your staff have not completed this outstanding program, I highly encourage you to do so. It can have a tremendous impact on your career.

Where are they now? John Kirtland

If you think you been involved with our Minnesota Chapter for a long time, let me re-introduce you to John Kirtland. You'd have to go way back to 1968 when he was our chapter president to compare stories about the good old days. Fortunately, John has stayed in contact with our organization over the years and was easy to catch up with for this article.

John started his career working in the aircraft industry in California just before Pearl Harbor. He was a flight engineer and co-pilot testing B25's on their maiden flights. Shortly thereafter, he enlisted in the Navy and eventually was stationed at Wold Chamberlain when the war ended. He courted his future wife, BettyAnn, on the shores of Lake Calhoun and they were married in February 1947.

John started his public works career with the Hennepin County Highway Department on a survey crew and as an inspector. An early memory was his supervision of the concrete paving of County Road 15 through Wayzata, Spring Park, and Mound. After a short three months as the assistant, John inherited the maintenance engineer position when Erick Jensen unexpectedly passed away in April of 1952. John quickly realized he needed the professional support of other public works professionals as he assumed his new responsibilities.

It was in the very early 1950s that he remembers attending his first public works meeting at the University of Minnesota. The relationships that John made at those meetings were very helpful with future dealings.

The 1961 APWA Congress held in Minneapolis opened his eyes to the enormous amount of information that was readily available. Through information gained at the various conferences, Hennepin County equipped their trucks with ground speed oriented spreaders and underbody plows, and the county was the first to use tandem trucks for snow plowing.

John was also instrumental in securing the county's first asphalt plant, a major step toward getting Hennepin County "out of the mud."

Since 1961, he attended every Congress (missing only one) and numerous Snow Conferences until he retired in 1985.

A personal high point for John's APWA-Minnesota involvement was when he developed the first Minnesota Inspector's School. He specifically mentioned the great work all the instructors did to make it a success. He also teamed up with Kent Lande (1974 APWA-MN president) to develop courses at North Hennepin College for public works personnel that continue to this day. John was also one of the original founders of the Minnesota Street Superintendents Association (MSSA).

A special memory for John was the 1968 chapter dinner in Miami when he was president. He fondly remembered the three APWA past presidents in attendance: **Hugo**

Erickson of Minneapolis, Milt Rosen of Saint Paul, and Edwin Booth of Bismarck.

Technology, Inc. (salt storage buildings) for the next 23 years! He called this his "dream job" because he continued to attend all the APWA Congresses and Snow Conferences and stayed in touch with his many contacts in the public works field.

John has always been the strongest of supporters of the public works profession, and a class act who was definitely a cornerstone in the foundation that makes our chapter what it is today.

Idea Center: More snow = less salt

Everybody knows chloride levels peak in downstream water bodies during the spring snow melt. And maybe everyone knows it only takes one teaspoon of salt to pollute 5 gallons of water forever.

But did you know that a proactive review of your salt application procedures and a few helpful hints put to practice can result in significant reductions in salt usage without compromising safety? Yeah right, I felt the same way.

The Challenge. When I first learned that the Nine Mile Creek Watershed District (NMCWD) was suggesting a 62 percent reduction in salt applications for its MS4 Cities, I quickly went from shocked to angry. Sixty-two percent sounded like an unrealistic goal, and our main concern was the compromised safety and reduced quality of service the traveling public would encounter.

I spent a fair amount of office time lamenting with Richfield Street Operations Manager Chris Link about NMCWD's wild and unrealistic allocations. But, instead of waiting for the MPCA to tie the TMDL requirements to our MS4 permit, Chris and I registered for the Winter Maintenance of Roads Workshop offered by NMCWD to see what they had to offer.

From there, Chris quickly stepped up to test the reasonableness of such a lofty goal.

The Test. His plan of attack was simple and easy to implement:

All operations staff attended the free Winter Maintenance of Roads Workshop offered by NMCWD.

Based on what was learned at the workshop, staff:

- Calibrated the equipment.
- Adjusted application rates based on pavement temperature.
- Applied salt at the crown of the road rather than across the surface.
- Applied pretreated salt during colder weather events.

The Results. After one of the snowiest winters on record, Chris is proud to report that the Richfield Streets Department

reduced its salt usage by over 50 percent, without receiving one complaint or sacrificing the safety of the traveling public.

Chris is committed to ongoing reviews of the city's salt application methods and will continue to make changes that will offer further reductions in usage. He can be reached at (612) 861-9174.
