- 7:20** **Don't Get Run Over by Driverless Cars, the Impact of Autonomous Vehicles on Public Works**

Driverless cars will be here sooner than most people think and they will have a dramatic effect on public works, including the dimensions of roadways, the requirements for parking, and the capacity of infrastructure. This technology will change how Minnesotans commute, whether we will own vehicles, and how our future city streets and freeways will look. One hundred years ago, Minnesota had transitioned from a horse-based to a horseless-carriage-based transportation system within fifteen years, and with driverless technology already available in cars, the same rapid transition will happen again, probably in even less time. Tom Fisher will describe the effect of driverless technology on cities and the need for parking ramps and surface lots, as well as on-street parking and even residential garages and driveways. Tom will also briefly discuss the winners and losers of driverless technology.

- Perfecting Your Show**

All of us have a particular way we “show up” every day in our personal and professional lives. Although we may be cognizant of this, to a large extent we don't believe we have full control over our level of engagement, attitude, approach or interactions with others. Stated simply, when things are good, we feel/act good, and when things are bad we feel entitled to feel/act bad. What we fail to realize is that we actually have the ability to control how we think and feel (our “show”), and thus the results we produce. This course will take participants through a journey toward realizing the ways they give their power away, operate from the victim role and let others dictate how they feel and behave. We will also explore how to regain personal power, take real responsibility for the energy we bring to all situations, set effective boundaries, and learn why it's important to “tell a new story.” By the end of the course participants will have a new perspective on themselves and others and have the strategies they need to be successful despite any circumstances.

Although there is no doubt that leaders at all levels are faced with personnel and organizational challenges, the reality is that it is a leader's own “stuff” that always creates the biggest problems. We all are our own worst enemies, and we often create undue stress on ourselves and others because of our perceptions, reactions, unmanaged “stuff” and our level of comfort with our way of being in the world. Even though it's more attractive to externalize our problems and barriers to our success, the truth that they only person we can ever really control is our self. This course will challenge participants to examine their personal barriers to success and provide them with strategic ways to improve their approach to life and leadership. Participants can expect to leave with a new perspective on leadership, strategies to more effectively manage their personal and professional challenges, and feel more empowered to make the changes necessary to get out of their own way.

This session will demonstrate the interactive Smart City Infrastructure Tool and show attendees how MN2050 can use the tool to show the public, politicians, and professionals the extent, condition, and value of Minnesota infrastructure. The Smart City tool was developed over the past year as a cooperative project between the Minnesota State Auditor, the University of Minnesota, MN2050, the PCA, the Health Department, League of Minnesota Cities, and the Public Finance Agency. The initial rollout uses an interactive map to show drinking water, sanitary sewer, and auditor data for each city in Minnesota. In addition to demonstrating the current tool, the presentation will allow attendees to use the interactive touch screen and to comment on adding MN2050 survey data to the Smart City tool.

In 2015, the Minnesota Vikings announced they were acquiring the old Northwest Airlines headquarters campus in Eagan and would be developing a new practice facility and associated campus development on the site. Working with the City of Eagan, the Vikings are going through the process of an Alternative Urban Areawide Review (AUAR) for the redevelopment project. In this conference session, the City of Eagan will provide an update on the AUAR process, what the potential development layout may look like, and how the City of Eagan (and neighboring communities) is preparing for this major redevelopment.

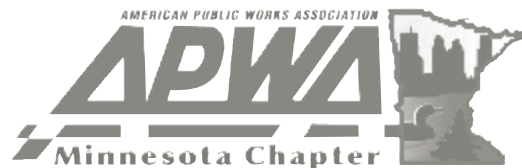
